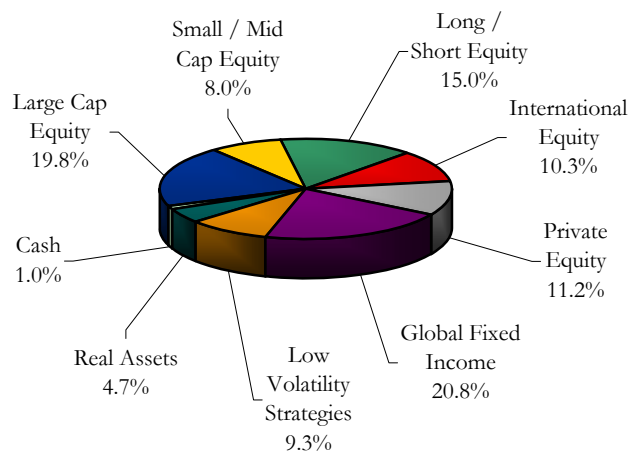
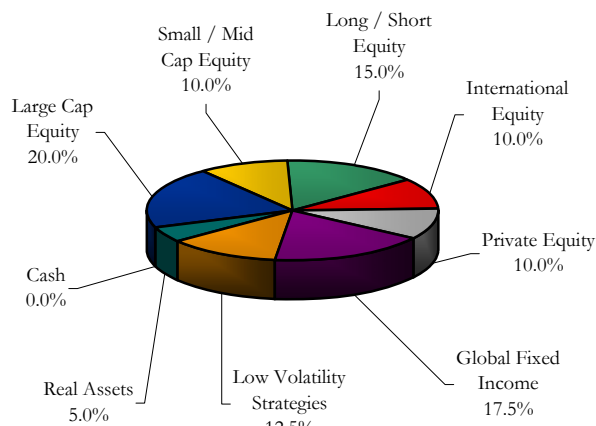

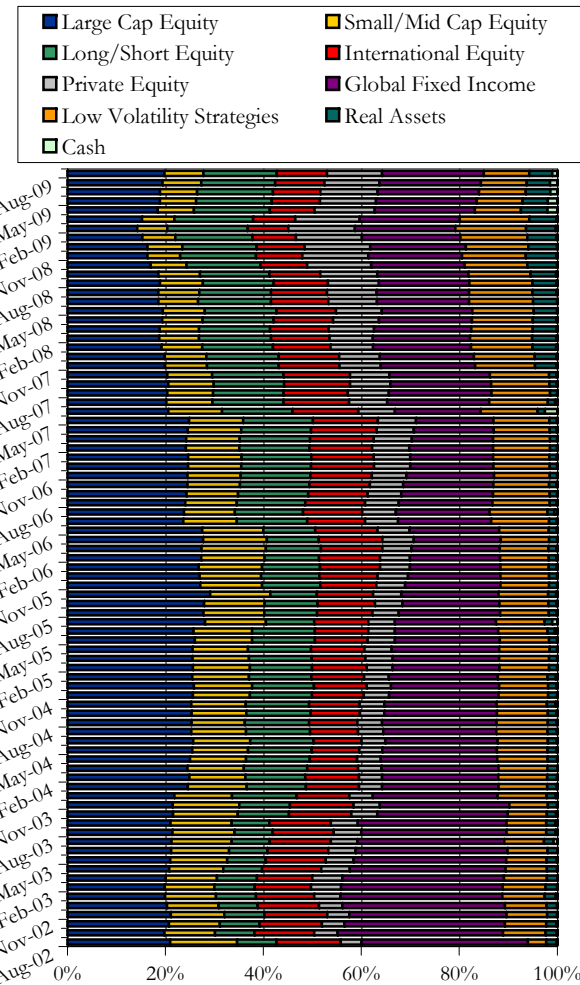
**Current Asset Allocation**
