ASSET CONSULTING GROUP - FINANCIAL CONSULTANT REPORT FOR MONTH ENDED DECEMBER 31, 2016 AND DISCUSSION ON REBALANCING PORTFOLIO ASSETS AMONG VARIOUS ASSET STRATEGIES AND MANAGERS. BOARD TO TAKE APPROPRIATE ACTION AS DEEMED NECESSARY.

Mr. George Tarlas reviewed the ASAP report for the month ended December 31, 2016, a copy of which is attached as Exhibit "E". As of December 31, 2016, the total Fund was approximately \$2,264,618,000.00. The one-year return net of fees for the total Fund is 7.09%.

Mr. Snyder advised the board that they had been supplied with information from the original 5 RFP responses as well as a new one from Jordan Strategies whom was recommended by the state FOP. He also advised that it was not the board's intent to hire a Legislative Consultant to go against the FOP but to work in conjunction with the FOP lobbyist. He also stated that a bill introduced by Rep.

Echols last session was still pending regarding a stipend/13th check. He stated with a \$900 million shortfall in state funds that we could be looking at possible negative impacts on the pension system.

Mr. Ryan Perkins stated he was concerned about possible issues that might come up as well as the stipend issue.

Mr. Ron Bartmier stated that the state FOP was in support of hiring a lobbyist for the one time issue of the stipend/13th check.

Mr. John George, President of Oklahoma City Fraternal Order of Police stated that his membership is opposed to hiring a Legislative Consultant of any type. He stated they did not see a need when the FOP already has a lobbyist.
