Ms. Ginger Sigler presented Oklahoma Attorney General Opinion 2019-1, a copy of which is attached at Exhibit "G", for discussion. Ms. Sigler advised that the board had asked for this opinion when it became aware that an Alternate Payee had been receiving part of a member's pension benefit via QDRO. The Alternate Payee had passed away and her beneficiary began receiving her portion of the benefit and had been receiving it since 2013. Ms. Sigler questioned the board's decision on this issue. She advised that she has written the Alternative Payees Beneficiary and told him the benefit had been suspended until the issue was resolved. Ms. Sigler said it was her intent to begin to pay the member's beneficiary the full amount immediately. No action was taken by the board.
