ASSET CONSULTING GROUP - FINANCIAL CONSULTANT REPORT FOR MONTH ENDED APRIL 30, 2021, QUARTERLY REPORT FOR QUARTER ENDED MARCH 31, 2021 AND DISCUSSION ON REBALANCING PORTFOLIO ASSETS AMONG VARIOUS ASSET STRATEGIES AND MANAGERS. BOARD TO TAKE APPROPRIATE ACTION AS DEEMED NECESSARY.

Mr. Jason Pulos reviewed the ASAP report for the month ended April 21, 2021, a copy of which is attached as Exhibit "F". As of April 30, 2021, the total fund was approximately \$3,155,679,000.00. The one-year return net of fees for the total fund is 28.77%. Mr. Pulos noted that it was the recommendation of Asset Consulting Group to commit \$40,000,000.00 to Blackstone Property Partners to rebalance the portfolio.
