updated for 2024. ACG would possibly have recommendations to reallocate the funds away from Long/Short Equity. The notice period for Long/Short Equity is 90+ days with quarterly liquidity. It was the recommendation of ACG to put in redemption notice for March 31, 2024, for all the Long/Short Equity funds and revisit in Jan/Feb 24 to discuss reallocation.
