Mr. George Tarlas and Jason Pulos reviewed the ASAP report for the month ended November 30, 2025, a copy of which is attached as Exhibit "F". As of November 30, 2025, the total fund was approximately \$3,603,137,000.00. The one-year return net of fees for the total fund is 9.47%.
